5. Please submit the bid on CUI-Lahore Campus prescribed BoQs with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.
6. Multiple rates of an item may also lead to the rejection of bid / item.
7. Purchase / work order shall be awarded on item wise basis.

5. The quotation should be submitted in a sealed envelope.

8. All prices should be quoted on F.O.R (Pak Rupees) and **valid for at least 60 days**.

9. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.

10. If the vendor fails to deliver the goods / services to COMSATS University Islamabad, Lahore Campus in time then the penalty will be charged as under:-

- a. 1% per day of the invoice price for 5 working days.
- b. 2% per day of the invoice price for further 5 working days.
- c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled.

11. The bid should be submitted in a sealed and stamped envelope up to **November 14, 2018 before 1400 Hrs** and will be opened on the same date at **1430 hrs** in the presence of available bidders.
