TERMS AND CONDITIONS

[All pages (BoQs & Terms & Conditions) are mandatory to be signed / stamped, Rates should be quoted on our prescribed format, failing which the bid may be rejected]

- 1. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS Institute of Information Technology, Lahore Campus.
- 2. Documents along with Pay Order / Demand Draft amounting **Rs. 500/-** as a tender documents fee (Non-Refundable) in favor of COMSATS Institute of Information Technology, Lahore to the address given below. No bid will be accepted without tender documents' fee.
- 3. Partial / Advance payments is not allowed.
- 4. The exact completion/delivery time from the date of the purchase / work order will be <u>40 days</u>. The handing over / completion time for this contract is of critical importance.
- 5. The bid proposal should be inclusive of all freight and packaging charges and will be delivered at Lahore Airport.
- 6. The payment will be made in Pak Rupees to the Local Vendor/Supplier against the conversion rate of actual GD-1(Conversion Rate) for C&F Quoted Items/Equipments as per following formula.

Foreign Currency (as per PO) x Conversion rate of GD-1 = Total Amount in Pak Rupees

- 7. Custom clearance will be cleared by COMSATS Lahore Campus.
- 8. After opening of bids COMSATS Institute of Information Technology, Lahore Campus will examine the bids for completeness as per tender document.
- 9. Any addition, deletion or modification of any clause of the procurement terms & conditions of CIIT by any vendor will not be acceptable and may lead to rejection of the bid.
- 10. Purchase order (s) will be awarded to the lowest or technically recommend bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 11. Bidders who do not qualify cannot challenge the finding of the evaluation or ask for reason of disqualification.
- 12. The bid should be submitted in a sealed envelope up to <u>July 08, 2015</u> on or before <u>1100 hrs</u> and will be opened on the same date <u>at 1130 hrs</u> in the presence of available bidders.
- 13. The envelope should be marked as under;

- 14. The envelope shall also bear the word "CONFIDENTIAL" and following identification quotation of "Cross Flow Cell for Chemical Engineering Department.".
- 15. The bid form (Annex-I/BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.

- 16. If the vendor fails to deliver the goods / services to CIIT-Lahore in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order will be cancelled, earnest money and payment will be forfeited.
- 17. If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- 18. Deduction of Income Tax and other taxes of any will be deducted at source according to Government prevailing rules.
- 19. Payment will be made on submission of Invoice in the name of "COMSATS Institute of Information Technology, Lahore Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery / installation, and COMSATS acceptance / inspection thereof.
- 20. All prices should be quoted on <u>C&F with all freight charges at Lahore Airport.</u>
- 21. All prices should be valid for at least <u>90 days.</u> Withdrawal or any modification of the original offer within the validity period shall entitle CIIT to forfeit the earnest money in favor of the CIIT and / or put a ban on such vendor participation in CIIT tenders / works.
- 22. It is the sole responsibility of the agent / supplier / manufacturer to comply with the applicable laws, be national or international.
- 23. In case of any dispute, decision of the Director, CIIT will be final and binding upon the parties.
- 24. The CIIT reserves the right to modify equipment quantities at any time before the award of work.
- 25. The bidder is required to furnish in form of Bank deposit / CDR / Pay order equivalent to 2% of the total Bid price as Earnest Money crossed in favor of "COMSATS Institute of Information Technology, Lahore Campus". Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.
- 26. COMSATS Institute of Information Technology, Lahore Campus, reserves the rights to accept or reject if;

No offer of a supplier/firm will be considered: -
