
TERMS AND CONDITIONS

[All pages (BoQs & Terms & Conditions) are mandatory to be signed / stamped, failing which the bid may be rejected.)

- 1. Any addition, deletion or modification of any clause of the procurement terms & conditions/BoQs of CIIT by any vendor will not be acceptable and may lead to rejection of the bid.
- 2. Only registered Suppliers, who are on Active Taxpayers List (ATL) of FBR, are eligible to participate in tender.
- 3. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS Institute of Information Technology, Lahore Campus.
- Documents along with Pay Order / Demand Draft amounting to <u>Rs. 500/-</u> as a tender documents fee (Non-Refundable) shall be submitted in favor of COMSATS Institute of Information Technology, Lahore to the address given below. No bid will be accepted without tender documents' fee.
- 5. Part / Advance payments is not allowed.
- The exact completion/delivery time from the date of the purchase / work order will be <u>90 days</u> (Start from the date of LC Opening). The handing over / completion time for this contract is of critical importance.
- 7. The bid proposal must be inclusive of all freight and packing charges and will be delivered at Lahore Airport.
- 8. L/C will be opened by the COMSATS Lahore Campus.
- 9. Shipment will be cleared by COMSATS Lahore Campus from Custom Authorities.
- 10. After opening of bids, COMSATS Institute of Information Technology, Lahore Campus will examine the bids for completeness as per tender document.
- 11. Purchase order (s) will be awarded to the lowest or technically recommended bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 12. Bidders cannot challenge the finding of the evaluation or ask for reason of disqualification.
- 13. The bid should be submitted in a sealed envelope up to <u>October 05, 2016</u> on or before <u>1400hrs</u> and will be opened on the same date <u>at 1430hrs</u> in the presence of available bidders.
- 14. The envelope should be marked as under; Secretary, Purchase Committee COMSATS Institute of Information Technology, La

- 15. The envelope shall also bear the word "CONFIDENTIAL" and following identification quotation of <u>"Gas Permeation Setup for Chemical Engineering Department, CIIT-Lahore".</u>
- 16. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- 17. If the vendor fails to deliver the goods / services to CIIT-Lahore in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
- 18. If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- 19. Deduction of Income Tax and any other tax will be deducted at source according to Government prevailing rules.
- 20. Payment will be made on submission of Invoice in the name of "COMSATS Institute of Information Technology, Lahore Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery / installation, and COMSATS acceptance / inspection thereof.
- 21. All prices should be quoted on C&F basis including all freight & packing charges.
- 22. All prices should be valid for at least <u>60 days.</u> Withdrawal or any modification of the original offer within the validity period shall entitle CIIT to forfeit the earnest money in favor of the CIIT and / or put a ban on such vendor participation in CIIT tenders / works.
- 23. It is the sole responsibility of the agent / supplier / manufacturer to comply with the applicable laws, be national or international.
- 24. <u>05%</u> of the total value of the <u>Invoice</u> will be retained as security by COMSATS Institute of Information Technology, Lahore Campus, and will be released after <u>One Year</u>, from the date of delivery / completion of work / supply.
- 25. In case of any dispute, decision of the Director, CIIT will be final and binding upon the parties.
- 26. The CIIT reserves the right to modify the quantities of goods / services at any time before the award of purchase / work order.
- 27. The bidder is required to furnish in form of <u>Bank deposit / CDR / Pay order equivalent to 2%</u> of the total Bid price as Earnest Money crossed in favor of "COMSATS Institute of <u>Information Technology, Lahore Campus"</u>. Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.
- 28. COMSATS Institute of Information Technology, Lahore Campus reserves the rights to accept or reject the bid if;
 - i. Received without earnest money
 - ii. Received later than the date and time fixed for tender submission
