- 2. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS Institute of Information Technology, Lahore Campus.
- Documents shall be submitted along with Pay Order / Demand Draft amounting to <u>Rs. 500/-</u> as a tender documents fee (Non-Refundable) in favor of COMSATS Institute of Information Technology, Lahore to the address given below. No bid will be accepted without tender documents' fee
- 4. The exact completion/delivery time (will be 30 days) and it shall be counted from the issuance of the purchase / work order. The handing over / completion time for this contract is of critical importance.
- 5. Your bid proposal should be inclusive of freight and all other taxes up to delivery of goods / services at the premises of COMSATS Institute of Information Technology, Lahore Campus.
- 6. After opening of bids COMSATS Institute of Information Technology, Lahore Campus will examine the bids for completeness as per tender document.
- 7. Purchase order (s) will be awarded to the lowest or technically recommend bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 8. Bidders who do not qualify cannot challenge the finding of the evaluation or ask for reason of disqualification.
- 9. The bid should be submitted in a sealed envelope up to <u>March 09, 2016</u> on or before <u>1400 hrs</u> and will be opened on the same date <u>at 1430 hrs</u> in the presence of available bidders.
