- 7. Part / Advance payments is not allowed.
- 8. The exact date of Event is 04 Days (January 31st to February 3rd, 2019). Setup should be ready uptill 04:00 Pm on January 30, 2019. The handing over / completion time for this contract is of critical importance.
- 9. Your bid proposal should be inclusive of freight and all other taxes and to be delivered at CUI, Lahore Campus's premises.
- 10. After opening of bids, CUI, Lahore Campus will examine the bids for completeness as per tender document.
- 11. Purchase order (s) will be awarded to the lowest or technically recommended bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 12. The bid should be submitted in a sealed envelope up to <u>January 23, 2019</u> on or before <u>1400hrs</u> and will be opened on the same date at 1430hrs in the presence of available bidders.

- 15. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder
- 16. If the vendor fails to deliver the goods / services to CUI-Lahore Campus in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
