- The packing should contain a label showing verifiable/traceable catalogue / lot number of Chemicals.
- Certificate of Analysis must be provided with the delivery of Chemicals.
- Under no circumstances should re-packed chemicals be provided
- Multiple prices of an item may lead to the rejection of item/bid.
