- If the product offered by vendor, failed to meet the specifications / standards mentioned in the BOQ, it will be rejected straightaway no further consideration will be given. Also, if the offered product has better specifications than the requirement of BOQ it will be accepted.
- Multiple rates of an item may also lead to the rejection of bid / item.
- Purchase / work order shall be awarded on <u>item wise</u> basis.

- 8. All prices should be quoted on F.O.R (Pak Rupees) and valid for at least 40 days.
- 9. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
- 10. If the vendor fails to deliver the goods / services to COMSATS University Islamabad (CUI), Lahore Campus within the given deadline, any of the following can be opted by CUI Lahore campus on the recommendation of the end user and approval of the authority;
